## **PROJECT SUMMARY**

Socially India Included Foundation (SIIF) and NTTF joined hands and signed project agreement on 21st Sep 2018 to continue the project for designing and implementing a customized skill training program for victims of trafficking.

Under this project, a batch of 23 candidates was mobilized by JUSTICE AND CARE Bihar Team, the trainees selected hail from districts of Nawada, Gaya and Kishanganj. The candidates were trained over a period of 1 year (starting Mar 2018). During this one year the candidates were provided with 3 months of Foundation Course designed by Justice And Care and thereafter in multi skill trades such as Welding, Electrical, Fitter etc. The trained candidates were assisted with employment opportunities based on their age and aptitude

## **EXECUTIVE SUMMARY FOR PROJECT**

- 1. 23 Candidates completed one year training at NTTF Centre in Bhiwadi.
- 2. 7 candidates were offered and accepted placed in a factory in Bhiwadi.
- 1 candidate was offered placement in Tata Motors in Jamshedpur though he did not take it the offer as he did not want to stay alone in Jamshedpur.
- 4. Remaining candidates could not be placed as they were below 18 years of age.
- 5. 7 candidates are currently staying in NTTF centre while they are working. All remaining candidates have returned to their homes.
- 6. Project took 14 months to complete.


Majority of candidates selected are mainly the JUSTICE AND CARE Survivors from Operations- like Hydops, Ops Jaal and few from the community.

(Data presented is based on self-declaration of students)


The current age distribution of students:



## Field Counselling

During the project, SIIF Field Counsellor has been visiting families of the students undergoing training. All families are very happy about the progress of their ward. Many families want their other children to also undergo training at NTTF.



## Special Educator and Counsellor visit

Ms. Barkha Mohan, Special Educator and Counsellor visited NTTF Center once a month. She evaluated the students for their reading and learning difficulties and their social behaviour that was hindering the progress of some children. She conducted motivation classes for all children to help them realize their own unique strengths and empower them. Storytelling was used to convey the idea of uniqueness, their strengths and inter-dependence.

Screening of the identified children showed that they were functioning at pre-primary levels and showed no sound-symbol awareness. A structured phonic program along with regular counselling sessions was planned and implemented for the students.

NTTF Technical training staff were also given tips on handling children on a day-to-day basis.









## CONCLUSIONS/RECOMMENDATIONS

The training has helped groom the candidates' personalities and ignited passion in them to study further. Additionally, 8 candidates were also offered jobs after training completion. Remaining candidates could not be placed as they were below 18 years.

We should consider planning next batch of training of 25 to 30 candidates with learnings from the first batch:

- Select candidates who are in the age range of 16 to 20 years.
- Select candidates who have completed 8<sup>th</sup> class education
- Plan candidates to complete their 10<sup>th</sup> class exam from NIOS along with skill training
- Regular phonics and special education support to be provided along with skill training
- Budget and plan for at least one home visit during the one year of training
- Field counseling with parents of candidates to continue
- Budget for living expenses, warm clothes and medical exigencies
- Plan for their placement before training is completed
- Plan for handholding of candidates for approx. 6 months after training is over.
